**COMPLAINT FOR TRADEMARK INFRINGEMENT,  
UNFAIR COMPETITION, DILUTION, CONSUMER FRAUD  
AND DECEPTIVE TRADE PRACTICES**

1. Plaintiff AmeriCash Loans, LLC (hereinafter "AmcriCash") brings this complaint against defendants Americash Advance, LLC (hereinafter "Americash Advance"); Americash.org (hereinafter "Americash.org"); Americash-Online.com (hereinafter "Americash-Online"); Online-Cash-Advance.us (hereinafter "Online-Cash-Advance"); and Cash-Advance-Express.com (hereinafter "Cash-Advance-Express"); (hereinafter collectively "defendants") for defendants' infringement and dilution of AmeriCash's Federal Registered Mark, and unfair competition and deceptive trade practices. As its complaint against defendants, AmeriCash alleges as follows:

## NATURE OF THE ACTION

2. This is an action for service mark infringement, unfair competition and dilution pursuant to the Lanham Act, 15 U.S.C. § 1125(a); dilution pursuant to the Illinois Trademark Registration and Protection Act, 765 ILCS § 1036/65 and the common law of the State of Illinois; consumer fraud pursuant to the Illinois Consumer Fraud and Deceptive Business Practices Act, 815 Ill.Comp.Stat. § 505/1, *et seq.*; and deceptive trade practices under the Illinois Uniform Deceptive Trade Practices Act, 815 Ill.Comp.Stat. § 510/1, *et seq.*

3. The action results from, *inter alia*, defendants' infringement of AmeriCash's Federal Registered Mark, AMERICASH LOANS, through defendants' unauthorized use of the term AMERICASH on defendants' web sites, as domain names, and in advertising in connection with payday and installment loan services, and their offer to provide such services under the mark in interstate commerce.

## JURISDICTION AND VENUE

4. This Court has jurisdiction over this action pursuant to 28 U.S.C. §§ 1331 and 1338(a) and (b) (patent, copyright, trademark and unfair competition). This Court has jurisdiction over AmeriCash's related common law claim under 28 U.S.C. § 1367 (supplemental jurisdiction). Venue and personal jurisdiction are proper in the Northern District of Illinois under 28 U.S.C. § 1391(b), since, *inter alia*, a substantial part of the events or omissions giving rise to the claim occurred here, each of the defendants are doing business in this District, and defendants have advertised and promoted their installment loan services on their website, and provided services in connection with the AMERICASH mark in this District.

## THE PARTIES

5. AmeriCash is a Limited Liability Company organized and existing pursuant to the laws of the State of Delaware. AmeriCash has a principal place of business located within this district at 880 Lee Street, Des Plaines, Illinois 60016. AmeriCash is in the business of, *inter alia*, providing payday and/or installment loan services. AmeriCash provides a necessary service to those individuals that have a need for a payday loan for a short time frame, such as between paychecks. AmeriCash provides its services under its Federal Registered Mark AMERICASH LOANS. AmeriCash has continuously used its mark in connection with its installment services since as early as 1998.

6. Upon information and belief, Americash Advance is a Delaware corporation having a principal place of business at 901 Market Street, Suite 460, Wilmington, Delaware 19801. Americash Advance provides the identical services as AmeriCash, and has regularly and systematically engaged in business in this district by offering its services to the citizens of Illinois through its website.

7. Upon information and belief, Americash.org is a Nebraska corporation having a principal place of business in Omaha, Nebraska. Americash.org provides the identical services as AmeriCash, and has regularly and systematically engaged in business in this district by offering its services to the citizens of Illinois through its website.

8. Upon information and belief, Americash-Online is a Canadian corporation having a principal place of business at 2000-1066 West Hastings Street, Vancouver, British Columbia V6E 3X2 Canada. Americash-Online provides the identical services as AmeriCash, and has regularly and systematically engaged in business in this district by offering its services to the citizens of Illinois through its website.

9. Upon information and belief, Online-Cash-Advance is a California corporation having a principal place of business in San Francisco, California. Online-Cash-Advance provides the identical services as AmeriCash, and has regularly and systematically engaged in business in this district by offering its services to the citizens of Illinois through its website.

10. Upon information and belief, Cash-Advance-Express is a Georgia corporation having a principal place of business at 2000 Powers Ferry Road, Marietta, Georgia 30067. Cash-Advance-Express provides the identical services as AmeriCash, and has regularly and systematically engaged in business in this district by offering its services to the citizens of Illinois through its website.

11. Each of defendants' unlawful acts alleged in this Complaint have occurred in this district and/or are directed to cause, and have caused or will cause, injury to AmeriCash within this district.

#### **AMERICASH'S VALUABLE AMERICASH MARK**

12. Since as early as 1998, AmeriCash has continuously used its Federal Registered Mark in connection with a wide variety of loan services, including installment loan services. AmeriCash does not provide mortgage services and its Federal Registration is accordingly restricted from such coverage.

13. In September of 2005, the United States Trademark Office registered the service mark AMERICASH LOANS in connection with loan services, namely, installment loans, not including mortgage services and mortgage loans. Plaintiff AmeriCash is the rightful owner of this registration, U.S. Reg. No. 2,990,906. See Exh. A.

14. AmeriCash has continuously and prominently displayed and advertised the AMERICASH LOANS mark in its numerous business locations, and in connection with its installment loan services that it offers to customers and potential customers throughout Illinois. Since long before the acts of defendants described herein, AmeriCash had invested substantial time, effort and expense extensively promoting and advertising the AMERICASH LOANS mark in connection with its services, including the promotion and advertising of the AMERICASH LOANS mark in this district where each of the defendants is conducting business through its websites.

15. AmeriCash also owns the rights to the domain name: [www.americashloans.net](http://www.americashloans.net). See Exh. B.

16. As a result of the continuous high-profile advertising and promotion of the AMERICASH LOANS mark by AmeriCash, and the extensive services provided over the years in connection with the mark, the AMERICASH LOANS mark has become, through public acceptance and recognition, an asset of substantial value symbolizing AmeriCash, its quality services, and its goodwill.

#### **DEFENDANTS' UNAUTHORIZED USE OF THE AMERICASH MARK**

17. AmeriCash has never authorized, licensed or otherwise permitted any of the defendants to use the AMERICASH LOANS mark, or any confusingly similar variation thereof.

18. Without authorization, license or authority from AmeriCash, defendant Americash Advance has advertised the confusingly similar AMERICASH ADVANCE service mark on its website, and used the same as a domain name in connection with installment loan services. See Exh. C.

19. Without authorization, license or authority from AmeriCash, defendant Americash.org has advertised the confusingly similar AMERICASH.ORG service mark on its website, and used the same as a domain name in connection with installment loan services. See Exh. D.

20. Without authorization, license or authority from AmeriCash, defendant Americash-Online has advertised the confusingly similar AMERICASH ONLINE service mark on its website, and used the same as a domain name in connection with installment loan services. See Exh. E.

21. Without authorization, license or authority from AmeriCash, defendant Online-Cash-Advance has advertised the confusingly similar AMERICASH LOANS mark on its website, in connection with installment loan services. See Exh. F.

22. Without authorization, license or authority from AmeriCash, defendant Cash-Advance-Express has advertised the identical AMERICASH LOANS, and confusingly similar AMERICASH ADVANCE, AMERICASH ONLINE, AMERICASH, AMERI-CASH ONLINE LOANS, AMERICASH LOANS ONLINE, AMERICASH CASH ADVANCE, AMERICASH PAYDAY LOANS, AMERICASH EXPRESS, AMERICASH PAYCHECK LOANS, AMERICASH PAYDAY LOAN, AMERICASH ADVANCED, AMERI-CASH LOAN, AMERI-CASH, AMERICASH PAYDAY ADVANCE and AMERICASH-ONLINE service marks on its website, in connection with installment loan services. See Exh. G.

23. Upon information and belief, at the time each of the defendants first began engaging in the aforesaid acts, defendants had constructive notice of AmeriCash's trademark rights, and defendants knew or should have known of the valuable reputation and goodwill symbolized by AmeriCash's AMERICASH LOANS mark and its association with AmeriCash.

24. Upon information and belief, at the time defendants engaged in the acts complained of herein, defendants had actual knowledge of the valuable reputation and goodwill symbolized by AmeriCash's AMERICASH LOANS mark and its association with AmeriCash. Despite AmeriCash's prior rights, defendants adopted, used in advertising, used on their web sites, and used as domain names, service marks confusingly similar to AmeriCash's AMERICASH LOANS mark for the purpose of, and with the intention of, trading off of AmeriCash's goodwill and reputation.

**DEFENDANTS' USE OF AMERICASH'S SERVICE MARK  
HAS CAUSED ACTUAL CONFUSION AND MAKES CONFUSION LIKELY**

25. Americash Advance's use of the AMERICASH ADVANCE service mark in connection with its installment loan services has and is likely to continue to mislead, deceive, and confuse the purchasing public and the trade. Consumers have and will continue to conclude that Americash Advance is connected, associated or affiliated with AmeriCash.

26. Americash Advance's activities, as hereinabove pleaded, have and are likely to continue to cause confusion or mistake, or to deceive the consuming public and the trade as to the source or origin of the goods and services offered by AmeriCash and the sponsorship and/or endorsement of those goods by AmeriCash.

27. Americash Advance's activities, as hereinabove pleaded, have and are likely to continue to dilute the value of AmeriCash's AMERICASH LOANS mark by diminishing the public association of the mark with AmeriCash and working an adverse effect upon the distinctiveness of the mark, thus creating a likelihood of injury to AmeriCash's respected reputation.

28. Americash.org's use of the AMERICASH.ORG service mark in connection with its installment loan services is likely to mislead, deceive, and confuse the purchasing public and the trade. It is likely that consumers will conclude that Americash.org is connected, associated or affiliated with AmeriCash.

29. Americash.org's activities, as hereinabove pleaded, are likely to cause confusion or mistake, or to deceive the consuming public and the trade as to the source or origin of the goods and services offered by AmeriCash and the sponsorship and/or endorsement of those goods by AmeriCash.

30. Americash.org's activities, as hereinabove pleaded, are likely to dilute the value of AmeriCash's AMERICASH LOANS mark by diminishing the public association of the mark with AmeriCash and working an adverse effect upon the distinctiveness of the mark, thus creating a likelihood of injury to AmeriCash's respected reputation.

31. Americash-Online's use of the AMERICASH ONLINE service mark in connection with its installment loan services is likely to mislead, deceive, and confuse the purchasing public and the trade. Consumers will conclude that Americash-Online is connected, associated or affiliated with AmeriCash.

32. Americash-Online's activities, as hereinabove pleaded, are likely to cause confusion or mistake, or to deceive the consuming public and the trade as to the source or origin of the goods and services offered by AmeriCash and the sponsorship and/or endorsement of those goods by AmeriCash.

33. Americash-Online's activities, as hereinabove pleaded, are likely to continue to dilute the value of AmeriCash's AMERICASH LOANS mark by diminishing the public association of the mark with AmeriCash and working an adverse effect upon the distinctiveness of the mark, thus creating a likelihood of injury to AmeriCash's respected reputation.



34. Online-Cash-Advance's use of the AMERICASH ADVANCE service mark in connection with its installment loan services is likely to mislead, deceive, and confuse the purchasing public and the trade. Consumers will conclude that Online-Cash-Advance is connected, associated or affiliated with AmeriCash.

35. Online-Cash-Advance's activities, as hereinabove pleaded, are likely to cause confusion or mistake, or to deceive the consuming public and the trade as to the source or origin of the goods and services offered by AmeriCash and the sponsorship and/or endorsement of those goods by AmeriCash.

36. Online-Cash-Advance's activities, as hereinabove pleaded, are likely to dilute the value of AmeriCash's AMERICASH LOANS mark by diminishing the public association of the mark with AmeriCash and working an adverse effect upon the distinctiveness of the mark, thus creating a likelihood of injury to AmeriCash's respected reputation.

37. Cash-Advance-Express' use of the AMERICASH LOANS, AMERICASH ADVANCE, AMERICASH ONLINE, AMERICASH, AMERI-CASH ONLINE LOANS, AMERICASH LOANS ONLINE, AMERICASH CASH ADVANCE, AMERICASH PAYDAY LOANS, AMERICASH EXPRESS, AMERICASH PAYCHECK LOANS, AMERICASH PAYDAY LOAN, AMERICASH ADVANCED, AMERI-CASH LOAN, AMERI-CASH, AMERICASH PAYDAY ADVANCE and AMERICASH-ONLINE service marks in connection with its installment loan services is likely to mislead, deceive, and confuse the purchasing public and the trade. Consumers will conclude that Cash-Advance-Express is connected, associated or affiliated with AmeriCash.

38. Cash-Advance-Express' activities, as hereinabove pleaded, are likely to cause confusion or mistake, or to deceive the consuming public and the trade as to the source or origin

of the goods and services offered by AmeriCash and the sponsorship and/or endorsement of those goods by AmeriCash.

39. Cash-Advance-Express' activities, as hereinabove pleaded, are likely to dilute the value of AmeriCash's AMERICASH LOANS mark by diminishing the public association of the mark with AmeriCash and working an adverse effect upon the distinctiveness of the mark, thus creating a likelihood of injury to AmeriCash's respected reputation.

40. As a result of the aforesaid acts by defendants, AmeriCash has suffered and continues to suffer substantial damages and irreparable injury. AmeriCash has no adequate remedy at law, and unless defendants are restrained and enjoined by the Court, said acts will be continued and will continue to cause damage and irreparable injury to AmeriCash, and to damage its goodwill and business reputation. Because of the threatened continuation of loss of customers and sales, AmeriCash cannot ascertain the precise amount of its damages at this time.

**COUNT I  
FEDERAL TRADEMARK INFRINGEMENT  
VIOLATION OF SECTION 43(a) OF THE LANHAM ACT**

41. As its first ground for relief, AmeriCash claims violation of § 43(a) of the Lanham Act, 15 U.S.C. § 1125(a), based on federal trademark infringement. AmeriCash repeats and realleges the allegations of paragraphs 1 through 40 as if set forth fully herein.

42. Americash Advance's unauthorized use of the infringing service mark AMERICASH ADVANCE in interstate commerce has caused and is likely to cause confusion, mistake, or deception as to source, association or sponsorship with AmeriCash's AMERICASH LOANS mark. The relevant public has believed and is likely to believe Americash Advance's services originate with, are licensed by, sponsored by, connected with, or associated with AmeriCash. Americash Advance's unauthorized use of the infringing mark falsely represents

Americash Advance as being legitimately connected with AmeriCash, and places AmeriCash's reputation beyond AmeriCash's control.

43. Americash.org's unauthorized use of the infringing service mark

AMERICASH.ORG in interstate commerce is likely to cause confusion, mistake, or deception as to source, association or sponsorship with AmeriCash's AMERICASH LOANS mark. The relevant public is likely to believe Americash.org's services originate with, are licensed by, sponsored by, connected with, or associated with AmeriCash. Americash.org's unauthorized use of the infringing mark falsely represents Americash.org as being legitimately connected with AmeriCash, and places AmeriCash's reputation beyond AmeriCash's control.

44. Americash-Online's unauthorized use of the infringing service mark AMERICASH

ONLINE in interstate commerce is likely to cause confusion, mistake, or deception as to source, association or sponsorship with AmeriCash's AMERICASH LOANS mark. The relevant public is likely to believe Americash-Online's services originate with, are licensed by, sponsored by, connected with, or associated with AmeriCash. Americash-Online's unauthorized use of the infringing mark falsely represents Americash-Online as being legitimately connected with AmeriCash, and places AmeriCash's reputation beyond AmeriCash's control.

45. Online-Cash-Advance's unauthorized use of the infringing service mark

AMERICASH ADVANCE in interstate commerce is likely to cause confusion, mistake, or deception as to source, association or sponsorship with AmeriCash's AMERICASH LOANS mark. The relevant public is likely to believe Online-Cash-Advance's services originate with, are licensed by, sponsored by, connected with, or associated with AmeriCash. Online-Cash-Advance's unauthorized use of the infringing mark falsely represents Online-Cash-Advance as being legitimately connected with AmeriCash, and places AmeriCash's reputation beyond AmeriCash's control.

46. Cash-Advance-Express' unauthorized use of the infringing service marks AMERICASH LOANS, AMERICASH ADVANCE, AMERICASH ONLINE, AMERICASH, AMERI-CASH ONLINE LOANS, AMERICASH LOANS ONLINE, AMERICASH CASH ADVANCE, AMERICASH PAYDAY LOANS, AMERICASH EXPRESS, AMERICASH PAYCHECK LOANS, AMERICASH PAYDAY LOAN, AMERICASH ADVANCED, AMERI-CASH LOAN, AMERI-CASH, AMERICASH PAYDAY ADVANCE and AMERICASH-ONLINE in interstate commerce is likely to cause confusion, mistake, or deception as to source, association or sponsorship with AmeriCash's AMERICASH LOANS mark. The relevant public is likely to believe Cash-Advance-Express' services originate with, are licensed by, sponsored by, connected with, or associated with AmeriCash. Cash-Advance-Express' unauthorized use of the infringing mark falsely represents Cash-Advance-Express as being legitimately connected with AmeriCash, and places AmeriCash's reputation beyond AmeriCash's control.

47. AmeriCash has been and is being damaged by such trademark infringement and has no adequate remedy at law. Defendants' unlawful conduct will continue to damage AmeriCash unless enjoined by this Court.

**COUNT II  
FEDERAL UNFAIR COMPETITION  
VIOLATION OF SECTION 43(a) OF THE LANHAM ACT**

48. As its second ground for relief, AmeriCash hereby alleges federal unfair competition in violation of Section 43(a) of the Lanham Act, 15 U.S.C. § 1125(a). AmeriCash repeats and realleges the allegations of paragraphs 1 through 47 above, as though fully set forth herein.

49. Americash Advance's adoption and use of the AMERICASH LOANS mark, or approximations or simulations thereof, as hereinabove pleaded, constitutes use of a false designation of origin or a false representation, which wrongfully and falsely designates, describes or represents the origins of Americash Advance's services and business as originating from or being in connection with AmeriCash when this is not the case, and thereby constitutes a false description or representation used in interstate commerce.

50. Americash.org's adoption and use of the AMERICASH LOANS mark, or approximations or simulations thereof, as hereinabove pleaded, constitutes use of a false designation of origin or a false representation, which wrongfully and falsely designates, describes or represents the origins of Americash Advance's services and business as originating from or being in connection with AmeriCash when this is not the case, and thereby constitutes a false description or representation used in interstate commerce.

51. Americash-Online's adoption and use of the AMERICASH LOANS mark, or approximations or simulations thereof, as hereinabove pleaded, constitutes use of a false designation of origin or a false representation, which wrongfully and falsely designates, describes or represents the origins of Americash-Online's services and business as originating from or being in connection with AmeriCash when this is not the case, and thereby constitutes a false description or representation used in interstate commerce.

52. Online-Cash-Advance's adoption and use of the AMERICASH LOANS mark, or approximations or simulations thereof, as hereinabove pleaded, constitutes use of a false designation of origin or a false representation, which wrongfully and falsely designates, describes or represents the origins of Online-Cash-Advance's services and business as originating from or being in connection with AmeriCash when this is not the case, and thereby constitutes a false description or representation used in interstate commerce.

53. Cash-Advance-Express' adoption and use of the AMERICASH LOANS mark, or approximations or simulations thereof, as hereinabove pleaded, constitutes use of a false designation of origin or a false representation, which wrongfully and falsely designates, describes or represents the origins of Cash-Advance-Express' services and business as originating from or being in connection with AmeriCash when this is not the case, and thereby constitutes a false description or representation used in interstate commerce.

54. AmeriCash has been and is being damaged by such violation and has no adequate remedy at law. Defendants' unlawful and willful conduct will continue to damage AmeriCash unless enjoined by this Court.

**COUNT III  
FEDERAL DILUTION  
VIOLATION OF SECTION 43(c) OF THE LANHAM ACT**

55. As its third ground for relief, AmeriCash hereby alleges federal dilution in violation of Section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c). AmeriCash repeats and realleges the allegations of paragraphs 1 through 54 above, as though fully set forth herein.

56. Americash Advance's adoption and commercial use of the AMERICASH LOANS mark, or approximations or simulations thereof, as hereinabove pleaded, constitutes use in commerce of a mark or trade name after that mark has become famous, and causes dilution of the distinctive quality of the famous AMERICASH LOANS mark, and thereby constitutes dilution of the mark.

57. Americash.org's adoption and commercial use of the AMERICASH LOANS mark, or approximations or simulations thereof, as hereinabove pleaded, constitutes use in commerce of a mark or trade name after that mark has become famous, and causes dilution of the distinctive quality of the famous AMERICASH LOANS mark, and thereby constitutes dilution of the mark.

58. Americash-Online's adoption and commercial use of the AMERICASH LOANS mark, or approximations or simulations thereof, as hereinabove pleaded, constitutes use in commerce of a mark or trade name after that mark has become famous, and causes dilution of the distinctive quality of the famous AMERICASH LOANS mark, and thereby constitutes dilution of the mark.

59. Onlin-cash-advance.us' adoption and commercial use of the AMERICASH LOANS mark, or approximations or simulations thereof, as hereinabove pleaded, constitutes use in commerce of a mark or trade name after that mark has become famous, and causes dilution of the distinctive quality of the famous AMERICASH LOANS mark, and thereby constitutes dilution of the mark.

60. Cash-Advance-Express' adoption and commercial use of the AMERICASH LOANS mark, or approximations or simulations thereof, as hereinabove pleaded, constitutes use in commerce of a mark or trade name after that mark has become famous, and causes dilution of the distinctive quality of the famous AMERICASH LOANS mark, and thereby constitutes dilution of the mark.

61. AmeriCash has been and is being damaged by such violation and has no adequate remedy at law. Defendants' unlawful and willful conduct will continue to damage AmeriCash unless enjoined by this Court.

**COUNT IV**  
**VIOLATION OF ILLINOIS UNIFORM DECEPTIVE TRADE PRACTICES ACT**

62. As its fourth ground for relief, AmeriCash hereby alleges deceptive trade practice violation of the Illinois Uniform Deceptive Trade Practices Act, 815 Ill.Comp.Stat. § 510/1, *et seq.* AmeriCash repeats and realleges the allegations of paragraphs 1 through 61 above, as though fully set forth herein.

63. The Illinois Uniform Deceptive Trade Practices Act, 815 Ill.Comp.Stat. § 510/1, *et seq.*, provides that a person engages in deceptive trade practices when, *inter alia*, he “(1) passes off goods or services as those of another; ... (3) causes likelihood of confusion or of misunderstanding as to affiliation, connection or association with or certification by another; ... [or] (5) represents that goods or services have sponsorship, approval, characteristics, ... that they do not have....” regardless of whether or not there is “competition between the parties or actual confusion or misunderstanding.” 815 Ill.Comp.Stat. § 510/2.

64. Americash Advance’s unauthorized use of the AMERICASH LOANS mark, or approximations or simulations thereof, trades on the business reputation and good will of AmeriCash with the intention of deceiving the public into believing that Americash Advance is affiliated, connected or associated with AmeriCash in violation of the Illinois Uniform Deceptive Trade Practices Act, 815 Ill.Comp.Stat. § 510/1-7 (1965).

65. Americash.org’s unauthorized use of the AMERICASH LOANS mark, or approximations or simulations thereof, trades on the business reputation and good will of AmeriCash with the intention of deceiving the public into believing that Americash.org is affiliated, connected or associated with AmeriCash in violation of the Illinois Uniform Deceptive Trade Practices Act, 815 Ill.Comp.Stat. § 510/1-7 (1965).

66. As a result of its actions, as hereinabove pleaded, Americash Advance has misappropriated valuable property rights of AmeriCash, is trading on the goodwill of AmeriCash as symbolized by AmeriCash's distinctive AMERICASH LOANS mark, and has and is thereby likely to further confuse and deceive members of the purchasing public in violation of the common law of unfair competition of the State of Illinois.

87. As a result of its actions, as hereinabove pleaded, Americash.org has misappropriated valuable property rights of AmeriCash, is trading on the goodwill of AmeriCash as symbolized by AmeriCash's distinctive AMERICASH LOANS mark, and is thereby likely to confuse and deceive members of the purchasing public in violation of the common law of unfair competition of the State of Illinois.

88. As a result of its actions, as hereinabove pleaded, Americash-Online has misappropriated valuable property rights of AmeriCash, is trading on the goodwill of AmeriCash as symbolized by AmeriCash's distinctive AMERICASH LOANS mark, and is thereby likely to

confuse and deceive members of the purchasing public in violation of the common law of unfair competition of the State of Illinois.

89. As a result of its actions, as hereinabove pleaded, Online-Cash-Advance has misappropriated valuable property rights of AmeriCash, is trading on the goodwill of AmeriCash as symbolized by AmeriCash's distinctive AMERICASH LOANS mark, and is thereby likely to confuse and deceive members of the purchasing public in violation of the common law of unfair competition of the State of Illinois.

90. As a result of its actions, as hereinabove pleaded, Cash-Advance-Express has misappropriated valuable property rights of AmeriCash, is trading on the goodwill of AmeriCash as symbolized by AmeriCash's distinctive AMERICASH LOANS mark, and is thereby likely to confuse and deceive members of the purchasing public in violation of the common law of unfair competition of the State of Illinois.

91. AmeriCash has been and is being damaged by such violation and has no adequate remedy at law. Defendants' unlawful conduct will continue to damage AmeriCash unless enjoined by this Court.

### **PRAYER FOR RELIEF**

WHEREFORE, plaintiff AmeriCash Loans, Inc. demands:

1. That defendants, their officers, agents, servants, employees, licensees, attorneys, successors, related companies, parent companies, and assigns, and all those in active concert or participation with them, be forthwith preliminarily and thereafter permanently enjoined and restrained from:

a. Using the AMERICASH LOANS mark or any other similar mark, domain name or designation that is confusingly similar to the AMERICASH LOANS mark or gives rise

to a likelihood of confusion, mistake or deception with respect to AmeriCash's AMERICASH LOANS mark;

b. Doing any other act or thing likely to induce the mistaken belief that defendants or their services or business, is in any way approved by or affiliated, connected or associated with AmeriCash or AmeriCash's services; and

c. Unfairly competing with AmeriCash in any manner whatsoever or causing injury to the business reputation of AmeriCash.

2. That defendants be required to deliver for destruction all advertisements, brochures, current inventory of products, and related materials that utilize the AMERICASH LOANS mark or approximations or simulations thereof, and remove the same from any and all websites in their possession or control that bear the mark;

3. That an accounting be granted against defendants, and AmeriCash be awarded monetary relief in an amount to be fixed by the Court in its discretion as just, including:

a. All profits received by defendants from sales and revenues of any kind made as a result of their actions; and

b. All damages sustained by AmeriCash as a result of defendants' acts of infringement and unfair competition;

4. That defendants be directed to file with the Court and serve upon AmeriCash within thirty (30) days after issuance of an injunction, a report in writing and under oath setting forth in detail the manner and form in which defendants have complied with the injunction.

5. That because of the exceptional nature of this case, resulting from defendants' deliberate and willful infringement, this Court award AmeriCash reasonable attorneys' fees, costs and disbursements.

6. That AmeriCash shall have such other and further relief as this Court may deem just.

**JURY DEMAND**

Plaintiff hereby demands a trial by jury on all issues so triable.

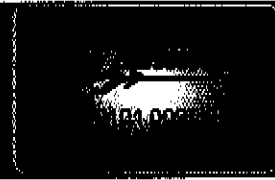

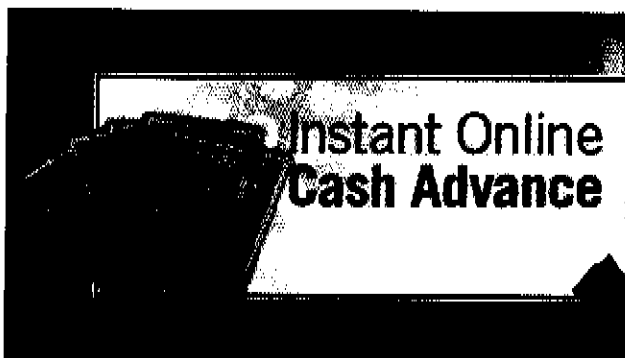

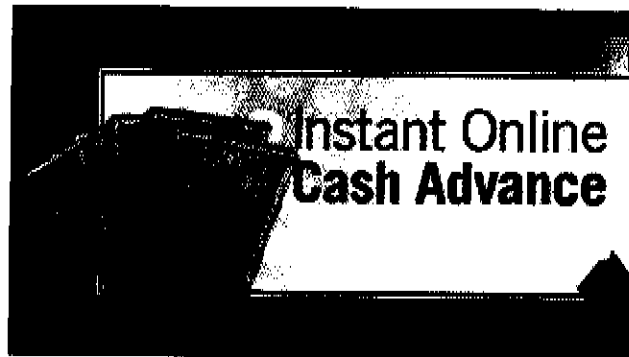
