I. THE PARTIES

1. Plaintiff, FabJob Inc. ("FabJob"), is an Alberta, Canada corporation with its principal place of business in Calgary, Alberta.

2. On information and belief, Defendant, Compana LLC ("Compana"), is a Wyoming limited liability company having a principal place of business in Carrollton, Texas.

II. JURISDICTION AND VENUE

3. This is an action arising out of the Anticybersquatting Consumer Protection Act, Pub. L. No. 106-113, 113 Stat. 1051 (enacted Nov. 29, 1999) (codified in 15 U.S.C. § 1125(d)), the Trademark Act of 1946, 15 U.S.C. § 1051 *et seq.*, the laws of the State of Washington, and the common law.

4. This Court has jurisdiction pursuant to 28 U.S.C. § 1331 (federal question), 15 U.S.C. § 1121 (actions arising under the Lanham Act), 28 U.S.C. § 1338 (acts of Congress

1 relating to trademarks and unfair competition), and 28 U.S.C. § 1367 (supplemental
2 jurisdiction over related state law claims). The amount in controversy exceeds the sum or
3 value of \$75,000.00.

4 5. Venue is proper in this jurisdiction under 28 U.S.C. § 1391.

5 6. This Court has personal jurisdiction over Defendant which, *inter alia*, conducts
6 business within this district, has committed a tortious injury within this district, and has
7 consented to jurisdiction in the state of Washington as recently as July, 2006.

8 **III. FABJOB'S TRADEMARK**

9 7. FabJob is in the business of selling and providing employment advice and
10 information through the internet and print media. Since as early as 2000, FabJob has used and
11 substantially invested in its trademarks FABJOB, FABJOB.COM and FROM DRAB JOB TO
12 FABJOB (collectively "the FABJOB marks"). Since at least as early as October 10, 2000,
13 FabJob has consistently marked the FABJOB marks with a TM symbol, thereby providing the
14 public with constructive notice of its rights in the mark. See Exhibits A-D, which are copies
15 of the FABJOB.COM home page as it appeared on October 10, 2000 (Exhibit A), October 29,
16 2001 (Exhibit B), December 11, 2001 (Exhibit C) and February 11, 2002 (Exhibit D). These
17 copies are drawn from *www.archive.org*, an independent, third-party web archival site.

18 8. FabJob is the owner of the trademarks FABJOB (U.S. Reg. No. 2795637 in
19 International Classes 009, 016 and 041) and FABJOB.COM FROM DRAB JOB TO FABJOB
20 (U.S. Reg. No. 2917697 in International Classes 009 and 041). FabJob obtained registrations
21 for the marks in the United States on December 16, 2003 and January 11, 2005, respectively.
22 Copies of these registrations and the associated Trademark Office records are attached hereto
23 as Exhibit E. To date, there are no other U.S. pending or registered marks incorporating the
24 term "fabjob." These registrations constitute *prima facie* evidence of FabJob's rights to use
25 the FABJOB marks as trademarks in association with the sale or promotion of the listed and
26 related goods and services.

1 9. FabJob is the registrant and owner of the domain name FABJOB.COM, which
2 it first registered on December 3, 1999. Exhibit F attached hereto is the domain name record;
3 Exhibit G attached hereto is a recent copy of the FABJOB.COM home page.

4 10. The FABJOB trademarks serve to identify FabJob's goods and services and
5 have come to be recognized by the purchasing public throughout the United States as an
6 indication of products of the highest quality. As a result, the FABJOB trademarks and the
7 goodwill associated with those marks represent substantial value owned by FabJob.

8 **IV. COMPANA'S INFRINGING ACTIVITIES**

9 11. On information and belief, Compana is engaged in a domain name
10 warehousing business whereby it registers domain names which are identical or similar to
11 established trademarks but that are misspelled, add additional words or letters, or, as in the
12 current case, are merely the plural form of the same word. Compana or its registrant then
13 establishes a web site with that domain name and sells the opportunity for "sponsors,"
14 including the trademark owner's competitors, to advertise and post links to their sites. Exhibit
15 H attached hereto is the first page of a reverse IP lookup for Compana's¹ IP address,
16 66.118.136.67, showing a total of 656,010 domain names registered with that IP address.

5 Exhibit I attached hereto are 159 domain names from this list that relate to "Seattle," provided
6 as an example of the types of domain names Compana registers.

7 12. This "business model" is in no way new for Compana; multiple UDRP
8 proceedings and civil lawsuits have been brought against the company. In many of the UDRP
9 proceedings, Compana was required to transfer the listed domain names to their proper owner
10 after a panel determined, according to a strict and established test, that Compana had no
11 legitimate rights in the domain names and had registered and used the domain names in bad
12 faith. Additionally, Compana has been involved in voluminous litigation over domain names
13 it has registered that misspell or incorporate someone else's trademark, including a recent case
14 in this judicial district, *Compana, LLC v. Aetna, Inc.*, Case No. 2:05-cv-00277RSL.³

15 13. A recent case before the National Arbitration Forum, involving the domain
16 name DOCFIND.COM, confirms the arbitrators no longer believe Compana's claims about
17 being ignorant of other's trademark rights:

18 This case is at least the sixth instance where this Respondent,
19 Compana LLC, has been a party to a domain name dispute wherein in each it
20 contends that it cannot be found to have registered the domain name in bad
21 faith because it had no knowledge of the trademark registration and of the
22 existence of the Complainant. Respondent's conduct in these six domain
23 name dispute cases brings the credibility of the Barron [sic] Affidavit into

24 ² While Compana is the registrar of these domain names and not the registrant, registrars can be held
25 liable for "bad faith intent to profit from" a domain name or the maintenance of a domain name. 15 U.S.C. §
26 1114(D)(iii). Regardless, Compana is both the registrar and registrant of the mark currently at issue.

27 ³ In this case, Compana registered the domain names AETNAL.COM, AETNANAVIAGATOR.COM
(a misspelling of Aetna's AETNANAVIGATOR.COM), AETNARXHOMEDELIVERY.COM (a misspelling
of Aetna's AETNARXHOMEDELIVERY.COM), AETNARXHOMEDELIVERIES.COM (identical to Aetna's
AETNARXHOMEDELIVERY.COM but with the plural "deliveries"), AETNACPLANS.COM, and
AETNAHOMERX.COM. The case was recently dismissed pursuant to a confidential, out-of-court agreement.

1 question. Considering Respondent's knowledge in acquiring domain names,
2 its utilization of same and its experiences in domain name disputes,
3 Respondent cannot be given the benefit of its alleged ignorance of the
4 trademark rights and existence of trademark registrants. Respondent's conduct
and allegation of ignorance of these facts suggest a pattern of bad faith
registration.

5 *See Aetna Inc. v. Compana LLC*, No. FA0409000330494 (Nat. Arb. Forum Nov. 20, 2004).

6 14. On or about June 2, 2002, Compana registered the domain name
7 FABJOBS.COM without the consent or authorization of FabJob. Compana's domain name is
8 identical to FabJob's trademark FABJOB with the exception of the added "s" which makes the
9 word into a plural. FabJob had been trying since 2001 to obtain the domain name
10 FABJOBS.COM from a cybersquatter in the United Kingdom who allowed the domain to
11 expire in 2002 after being contacted by FabJob. In an effort to obtain the name as soon as it
12 expired, FabJob back-ordered FABJOBS.COM through SnapNames, a company that obtains
13 expired domain names. However, Compana used an overseas registrar and was able to obtain
14 the name before SnapNames could get it. Since then, FabJob has tried repeatedly to contact
15 Compana through domain brokers at the email address Compana lists as its WHOIS
16 Administrative Contact, an address that under the ICANN WHOIS policy, Compana has a
17 duty to ensure is accurate. Compana has failed to respond. Exhibit J attached hereto is the
18 domain name record for FABJOBS.COM.

19 15. On information and belief, Compana provides goods and/or services through
20 the web site FABJOBS.COM. The domain name FABJOBS.COM as used by Compana in
21 relation to employment-related goods and/or services is confusingly similar to FabJob's
22 trademark FABJOB as used on similar goods. Exhibit K attached hereto is the
23 FABJOBS.COM web site as it is currently displayed.

24 16. On May 16, 2006, FabJob filed a complaint with the World Intellectual
25 Property Organization ("WIPO") in accordance with the Internet Corporation for Assigned
26 Names and Numbers ("ICANN") dispute resolution policy against Compana requesting that
27 FABJOBS.COM be transferred to FabJob.

1 17. On May 19, 2006, Compana filed a lawsuit in Texas state court requesting
2 declaratory judgment, injunctive relief and damages suffered as a result of FabJob's filing of
3 the WIPO complaint. The case was removed to federal district court in the Northern District
4 of Texas, Dallas Division on August 7, 2006 (Civil Action No. 3-06-CV-1402-L), where it
5 remains pending. That court is currently considering a motion for remand filed by Compana
6 and a motion to dismiss filed by FabJob.

7 18. On August 16, 2006, a one-person WIPO panel denied FabJob's complaint.
8 The WIPO panelist indicated that for the narrow issue of transfer of the domain name, it was
9 not immediately clear that Compana knew of FabJob's rights in the FABJOB mark at the time
10 of registration. Notably, the WIPO panelist did not have before him the evidence referenced
11 in Paragraphs 7 and 14, above. While there is no appeal through the UDRP procedures, the
12 issues may be litigated through the court system. FabJob has both evidence and additional
13 claims that it would now like addressed through this alternative avenue.

14 **V. CAUSES OF ACTION**

15 **COUNT I**

16 **VIOLATION OF THE ANTICYBERSQUATTING CONSUMER PROTECTION ACT**

17 **(15 U.S.C. § 1125(D))**

18 19. FabJob realleges Paragraphs 1-18 of this Complaint as if fully set forth herein.

19 20. Compana's use of the domain name FABJOBS.COM has caused and is likely
20 to continue to cause deception, mistake, or customer confusion as to the source of those
21 products. Furthermore, Compana's use of the domain name FABJOBS.COM creates the
22 mistaken impression that Compana's products and/or services are endorsed by FabJob or that
23 Compana's products and/or services are sponsored by, affiliated, or in some way connected
24 with FabJob.

25 21. Compana's activities described herein violate the Anticybersquatting
26 Consumer Protection Act, 15 U.S.C. § 1125(d), because they constitute willful and deliberate
27 use in commerce of a mark that was distinctive and subject to trademark protection at the time

1 Compana registered the domain name, and are identical and/or confusingly similar to
2 FabJob's registered marks and domain name. Compana's actions are performed with bad faith
3 intent to profit from the mark by creating confusion, mistake, and deception.

4 22. Compana's use of the domain name *FABJOBS.COM* is intentionally diverting
5 consumers attempting to find the FabJob web site. Compana's misappropriation of the
6 domain name is harming the goodwill earned and represented by FabJob's marks. Compana's
7 use of the domain name seeks commercial gain by creating confusion as to the source,
8 sponsorship, affiliation, and endorsement of Compana's web site.

9 23. Compana's selection of the domain name was not based in any way on
10 Compana's legal name or any other name used to identify Compana.

11 24. FabJob has been and continues to be irreparably damaged by Compana's
12 violations of this statute, and it has no adequate remedy at law. Unless restrained by this
13 Court, the violations will continue to cause injury to FabJob and the public.

14 **COUNT II**

15 **FEDERAL TRADEMARK INFRINGEMENT**

16 25. FabJob realleges Paragraphs 1-24 of this Complaint as if fully set forth herein.

17 26. *FabJob is the owner of the registered trademark FABJOB and incorporates that*
18 *trademark in its primary domain name FABJOBS.COM.*

19 27. Compana is, without consent of FabJob, using the mark *FABJOBS* in
20 connection with the sale, offering for sale, distribution, or advertising of goods and services in
21 such a way as is likely to cause confusion, or to cause mistake, or to deceive. Compana's
22 activities described herein constitute trademark infringement in violation of Section 32 of the
23 Lanham Act, 15 U.S.C. § 1114.

24 **COUNT III**

25 **UNFAIR COMPETITION UNDER SECTION 43(A) OF THE LANHAM ACT**

26 28. FabJob realleges Paragraphs 1-27 of this Complaint as if fully set forth herein.

27

1 29. Compana's activities described herein constitute false designation of origin in
2 violation of Section 43(a) of the Lanham Act, 15 U.S.C. § 1125.

3 **COUNT IV**

4 **COMMON LAW TRADEMARK INFRINGEMENT**

5 30. FabJob realleges Paragraphs 1-29 of this Complaint as if fully set forth herein.

6 31. Compana's activities described herein constitute trademark infringement in
7 violation of the common law of the state of Washington.

8 **COUNT V**

9 **VIOLATION OF THE WASHINGTON STATE CONSUMER PROTECTION ACT**

10 32. FabJob realleges Paragraphs 1-31 of this Complaint as if fully set forth herein.

11 33. Compana's activities described herein constitute unfair trade practices and
12 unfair competition in violation of the Washington State Consumer Protection Act, R.C.W.
13 § 19.86 *et seq.*

14 **VI. PRAYER FOR RELIEF**

15 Wherefore, FabJob respectfully prays this Court enter judgment in its favor against
16 Compana and provide to FabJob the following alternative and cumulative relief:

17 1. Issuance of a temporary restraining order and preliminary injunction enjoining
18 and prohibiting Compana, its agents, servants, employees, officers, successors, and assigns,
19 and all persons, firms and corporations acting in concert or in participation with Compana or
20 on Compana's behalf, from using or transferring the domain name FABJOBS.COM or any
21 other domain names that includes "fabjob";

22 2. Issuance of an order compelling Compana to transfer the domain name at issue
23 to FabJob;

24 3. Entry of judgment awarding FabJob compensatory and exceptional damages to
25 be paid by Compana pursuant to 15 U.S.C. § 1117, R.C.W. § 19.86.090 and all other
26 applicable laws;

1 4. Entry of judgment awarding FabJob its reasonable attorney's fees and costs
2 incurred in this matter to the fullest extent allowed by law; and

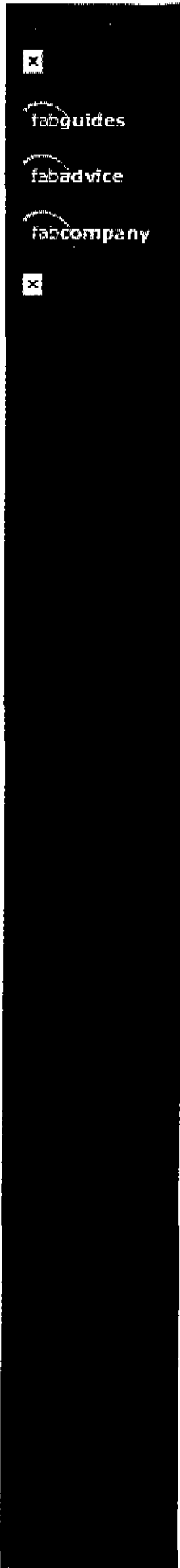
3 5. For such other and further relief as this Court may deem just and proper.
