Defendants

This matter came before the Court on the Motion For Order To Publish Notice Of *In Rem* Action filed by Plaintiff Tequila Cuervo La Rojeña S.A de C.V. ("Tequila Cuervo" or "Plaintiff"). Having examined the motion, the pleadings, and the submissions of the parties, and being fully informed, the Court finds as follows:

1. This is an *in rem* action brought by Plaintiff regarding the domain name <CUERVO.CN> (the "Domain Name") pursuant to the federal Anticybersquatting Consumer Protection Act, 15 U.S.C. § 1125(d) (the "Act"). Through this action, Plaintiff seeks an order to transfer the Domain Name to Plaintiff.

- 2. The Domain Name is or has been registered to defendants Stenli Ltd., Leigh Heggenhougen, Trond Heggenhougen (collectively, the "Registrant Defendants"), who reside outside of the United States.
- 3. With respect to service of process on the Registrant Defendants, the Act provides that in *in rem* actions such as this one, service of process shall be made by:
 - (aa) sending a notice of the alleged violation and intent to proceed under this paragraph to the registrant of the domain name at the postal and e-mail address provided by the registrant to the registrar; and
 - (bb) publishing notice of the action as the court may direct promptly after filing the action.

15 U.S.C. § 1125(d)(2)(A)(ii)(II)(aa) and (bb).

- 4. Plaintiff has complied with the requirements of subsection (aa) above by providing the Registrant Defendants with notice via email and mail of the alleged violation and intent to proceed under the Act. Thus, all that remains to complete service of process on the Registrant Defendants is the published notice under subsection (bb), as may be directed by the Court.
- 5. The London Gazette is an established means of providing notice in the United Kingdom, and published notice of this action in that publication is reasonable under the circumstances and complies with the Act and subsection (bb) above. On its website, the London Gazette described itself as the "Official Newspaper of Record for the UK and a modern, efficient way to disseminate and record official, regulatory and legal information in print, online and electronic forms." www.london-gazette.co.uk.
