I. CONFESSION OF JUDGMENT

Defendant Victoria Marticek ("Marticek") confesses and consents to judgment in favor of Plaintiff Wizards of the Coast LLC ("Wizards") and authorizes the Court to enter judgment granting monetary and permanent injunctive relief in favor of Wizards and against Marticek as set forth below.

Marticek confesses and consents to judgment as follows:

1 1. Marticek consents to this Court's jurisdiction over the subject matter at issue in
2 this action.

3 2. Marticek consents to this Court's personal jurisdiction over her for the
4 purposes of entry and enforcement of this Final Judgment on Consent and all related matters.

5 3. Marticek consents to entry of this judgment for monetary relief against her and
6 in favor of Wizards as a remedy for Marticek's manufacture, marketing, distribution and sale
7 of counterfeit cards related to Wizards' trading card game product Magic: The Gathering®
8 ("Magic"). Marticek recognizes that these actions undermined the integrity and brand
9 proposition of Magic and its tournament system, as alleged in the Complaint appended hereto
10 as Exhibit A. Marticek consents to entry of such judgment in the total amount of Fourteen
11 Thousand Five Hundred Dollars (\$14,500).

12 4. Marticek consents to entry of this judgment for permanent injunctive relief
13 against her and in favor of Plaintiff Wizards immediately, permanently, and forever enjoining
14 Marticek, her agents, representatives, and any other persons in active concert or participation
15 with her who receive actual notice of this Final Judgment on Consent by personal service or
16 otherwise from directly or indirectly infringing any of Wizards intellectual property rights,
17 including without limitation, making, manufacturing, distributing, selling or otherwise
18 offering, whether commercially or otherwise, counterfeit Magic trading cards.

19 5. Marticek agrees and stipulates that this Final Judgment on Consent is final and
20 may not be appealed by either party.



1 3. Judgment for monetary relief is awarded against Marticek and in favor of
2 Plaintiff Wizards of the Coast LLC in the amount of Fourteen Thousand Five Hundred
3 Dollars (\$14,500).

4 4. Judgment for permanent injunctive relief is awarded against against her and in
5 favor of Plaintiff Wizards immediately, permanently, and forever enjoining Marticek, her
6 agents, representatives, and any other persons in active concert or participation with her who
7 receive actual notice of this Final Judgment on Consent by personal service or otherwise from
8 directly or indirectly infringing any of Wizards intellectual property rights, including without
9 limitation, making, manufacturing, distributing, selling or otherwise offering, whether
10 commercially or otherwise, counterfeit Magic trading cards.

11 5. Each party shall bear its or his own attorneys' fees, costs, and expenses.

12 6. Given Marticek's confession of judgment, there is no just reason to delay entry
13 of final judgment against her. *See Fed. E. Civ. P. 54(b).*

14 7. *The parties stipulate that*
This Final Judgment on Consent may not be appealed by either party.
